The reason for seeking information in 48 hours is related to section 125 Indian Penal Code (IPC) dealing with imprisonment for life which reads as follows</p> <p>Whoever wages war against the Government of any Asiatic Power in alliance or at peace with the Government of India or attempts to wage such war, or abets the waging of such war, shall be punished with imprisonment for life, to which fine may be added, or with imprisonment of either description for a term which may extend to seven years, to which fine may be added, or with fine.</p> <p>Accordingly the following very specific information is required by me in larger public interest.</p> <p>1. Kindly provide me the particulars of the Asiatic Powers</p>		

included within section 125 IPC.

2. Kindly provide the information of the relevant alliances between the aforesaid Asiatic Powers and the Government of India for purposes of section 125 IPC along with the page specific URLs where these alliances can be authentically accessed on websites of the Government of India, or alternatively on the website of the concerned Asiatic Power or the Alliance organisation.

3. Kindly provide me the particulars of the Asiatic Powers which are presently at peace with the Government of India

4. Kindly provide me the particulars of the Asiatic Powers which are presently not at peace with the Government of India along with the copy(s) of the relevant official notification(s) or announcement(s).

5. Kindly provide me the complete information of the Asiatic Powers which have not been at peace with the Government of India at any time in the past 10 years along with the copy(s) of the relevant official notification or announcement and inter alia to establish the critical dates

6. Kindly provide me the information of all Asian nations which are not presently classified as Asiatic Powers.

7. In terms of the URL at <https://www.mea.gov.in/indian-foreign-service.htm> kindly provide me the index(s) and catalog(s) of all information maintained relating to the correspondence between the Government of India and the Mughal Empire of Emperor Akbar II between 1806 to 1837 carried out by/through the Foreign and Political department of the British India government which is stated by MEA to be predecessor of the Indian Foreign Service.

8. Kindly provide me the very specific information of all the dates / time periods after the critical date of September 13, 1783, when the Mughal Empire in India was not at peace with the Government of India.

9. Kindly provide me the particulars of all friendly countries to India

10. Kindly provide me the information of all monies or SDRs etc India has contributed for BRICS or deposited with the Banks established under BRICS

11. Kindly provide me the information of all monies or SDRs etc India has contributed for Quad or deposited with the Banks established under Quad
