

Kindly give me the complete information maintained till date i.e. 23rd December 2017 in the official records of Government of India by which India became a Commonwealth Country.

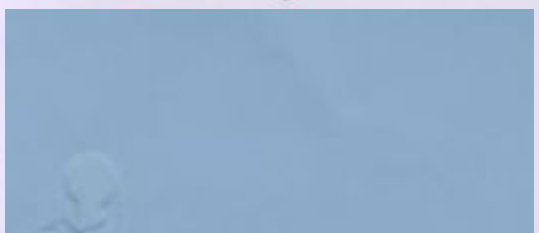
2. Kindly give me the information vide attested copies of the documents on the advantages which India enjoys till date i.e. 23rd December 2017 being a part of Commonwealth Country.
