Please refer to your RTI application dated 26/8/2018 addressed to Ministry of Home Affairs, which was transferred to RTI Cell, Ministry of External Affairs (MEA), New Delhi and received by this Division on 10/09/2018. with registration No – MHOME/R/2018/52507.

2. The information with respect to your query pertaining to the undersigned CPIO is as follows:

Indian territory under the occupation of China in Jammu & Kashmir is approximately 38,000 sq. kms. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. Kms. of Indian territory in Pakistan Occupied Kashmir to China.

The fact that the State of Jammu & Kashmir is an integral and inalienable part of India has been clearly conveyed to the Chinese side on several occasions, including at the highest level.

3. If you are aggrieved with this reply, you may file an appeal to Shri Amit Telang, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi – 110011, within a month from the date of receipt of this letter.


