Please refer to you RTI application dated 28 February 2019 addressed to RTI Cell, Ministry of External Affairs, New Delhi, received by this Division on 1 March 2019.

2. The information pertaining to the undersigned CPIO with respect to Point No. 3 of your query is as follows:

China is under occupation of approximately 38,000 sq. Kms of Indian territory in the state of Jammu & Kashmir. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. kms. of Indian territory in Pakistan Occupied Jammu & Kashmir to China.

The fact that Jammu & Kashmir is an integral and inalienable part of India, has been clearly conveyed to the Chinese side on several occasions, including at the highest level.

3. If you are aggrieved with this reply, you may file an appeal to Dr. Amit Telang, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi – 110011, within a month from the date of receipt of this letter.
