Sir,

Please refer to you RTI application dated 05 March 2019 addressed to Ministry of Defence, which was transferred to RTI Cell, Ministry of External Affairs, New Delhi, and received by this Division on 6 March 2019.

The information pertaining to Points No. 6 & 7 is as follows: 2.

China is under occupation of approximately 38,000 sq. kms of Indian territory in the state of Jammu & Kashmir. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. kms. of Indian territory in Pakistan Occupied Jammu & Kashmir to China.

The fact that Jammu & Kashmir is an integral and inalienable part of India, has been clearly conveyed to the Chinese side on several occasions, including at the highest level.

- Requested information at Point No. 4 of your RTI query is not available with 3. the undersigned CPIO.
