Please refer to your RTI application which was received in this Ministry on 14 March 2019.


2. The response to your RTI application is as follows:

Government of India has undertaken a series of initiatives, both at bilateral and multilateral levels, in pursuance of permanent membership for India in an expanded and reformed UN Security Council. We work alongside reform oriented countries including through groupings like the G-4 (India, Japan, Brazil and Germany) and L.69 (made up of cross regional developing countries). India is also actively engaged in the ongoing Intergovernmental Negotiations on UNSC reform at the United Nations and has been working towards 'text based negotiations'.

A large number of countries have supported India's candidature for permanent membership in an expanded UN Security Council. This has been expressed in various forms and fora including in bilateral discussions. India's performance as a non-permanent member of the UN Security Council during 2011-12 has also significantly strengthened India's claim to permanent membership.
