All countries recognised by India have diplomatic relations with us. Such countries are either represented in India through their Embassy, Ambassadors accredited in third country capitals or Honorary Consuls. No list of such countries available with this Division. In reply to your second question CPIO provided the information available with him. As the information requested may be available with several other CPIOs in the Ministry, the question number (i) & (ii) of your RTI
