2. The applicant sought information as below:

kindly inform if property owner is required to pay property tax for a property completely let out to an Embassy for the actual running of an embassy keeping in view Article 23 of the Vienna Convention which exempts premises of the mission "whether owned or leased" (information asked for 2004 to 2012).

3. The following is the response of the CPIO:

As per Article 23 (1) of Vienna Convention of Diplomatic Relations (VCDR) "the sending State and the head of the mission shall be exempt from all national, regional or municipal dues and taxes in respect of the premises of the mission, whether owned or leased, other than such as represent payment for specific services rendered. However, As per Article 23(2) of VCDR "The exemption from taxation referred to in this article shall not apply to such dues and taxes payable under the law of the receiving State by persons contracting with the sending State or the head of the mission".

4. In case the applicant is not satisfied with the response given by the undersigned, the applicant may file an appeal within 30 days of the receipt of this communication to Shri Sanjay Verma, Chief of Protocol and First Appellate Authority, Room No. 2001, Jawaharlal Nehru Bhawan, Ministry of External Affairs, 23D, Janpath, New Delhi-110011.
