2. In the current financial year 2016-17, UNP Division has paid Rs. 90.5 crore towards Government of India's contribution to the United Nations Organization. During the last three years this division paid Rs. 137.8 crore, Rs. 150.59 crore, Rs. 237.37 crore for the year 2013-14, 2014-15 and 2015-16 respectively towards United Nations Organization.

3. Since the subject of information of RTI application, also pertains to the work domain of UNES, WANA and D&ISA Division, the RTI application, is therefore, transferred to them under the provisions of Sub-section 6(3) of Right to Information Act 2005. UNES, WANA and D&ISA Division are requested to provide information directly to the applicant. Giving this reply, your RTI query is disposed-off.
