Sir,

Please refer to your RTI application dated 5/10/2016 addressed to Ministry of Home Affairs and was transferred to RTI Cell, Ministry of External Affairs.

2. The response to your query w.r.t. China is as follows:

China disputes the international boundary between India and China. Indian territory under the occupation of China in Jammu & Kashmir is approximately 38,000 sq. kms. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. kms. of Indian territory in Pakistan Occupied Kashmir to China. The fact that Jammu & Kashmir is an integral and inalienable part of India has been clearly conveyed to the Chinese side on several occasions, including at the highest level.

3. If you are aggrieved with this reply, you may file an appeal to Shri Sujit Ghosh, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi – 110011, within a month from the date of receipt of this letter.
