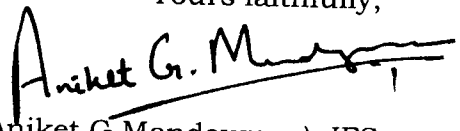
All the information related to the visits and outcomes of visits of Prime Minister (since 2001) is available in the "Outgoing Visits" section of the website.
