2. This CPIO deals with Malaysia, Singapore and Thailand only. As per information available with this CPIO the details of the visits of the officers of Southern Division to Malaysia, Singapore and Thailand, from November 2014 since when this CPIO joined this Division, is given below:

**March 2015:** DS (South) visited Singapore in connection with the visit of Prime Minister Modi to Singapore to attend the funeral ceremony of Lee Kuan Yew, the founding Prime Minister of Singapore.

**May 2015:** DS(South) visited Kuala Lumpur from 6-8 May, 2015 to take follow-up action on issues emerged on Secy (East)'s visit to Malaysia and to conduct discussions with the Malaysian authorities on the various pending issues as preparation for the forthcoming Joint Commission Meeting (JCM) as well as the proposed visit of Hon'ble Prime Minister of India to Malaysia.

**June 2015:** AS(South), and DS(South) visited Thailand, Bangkok in connection with the Joint Commission Meeting between the two Foreign Ministers. The whole lot of bilateral engagements between the two countries were reviewed and four Agreement/MoUs were signed.

**August 2015:** AS (South) and DS(South) visited Kuala Lumpur in connection with MOS(VKS)'s visit there to attend the ASEAN/EAS FM level meeting and bilateral meetings.

**November 2015:** AS (South) and DS (South) visited Kuala Lumpur in connection with PM's visit to Kuala Lumpur to attend the ASEAN/EAS Summits and bilateral meetings.

**November 2015:** AS (South) visited Singapore in connection with PM's bilateral visit to Singapore.

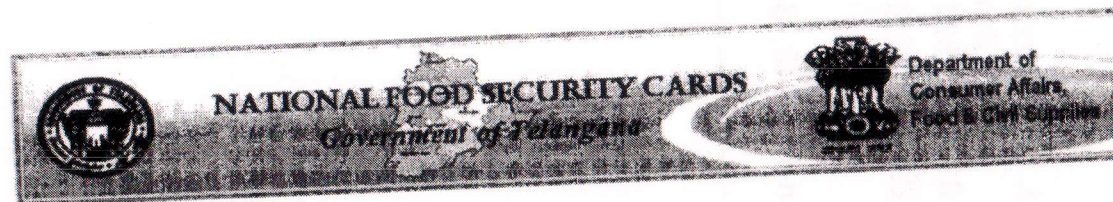
