Query 1-3: While extending invitations to media organizations to be part of the media delegation during Prime Minister's visits abroad, efforts are made to ensure adequate, balanced and fair representation of all major media organizations – both Public Broadcasters and Media Agencies which include audio visual and print media. These are Doordarshan, AIR, Photo Division and National News Agencies – PTI, UNI, ANI TV etc. The media organizations/agencies are requested to nominate representative having wide experience in foreign affairs and issues relevant to the visit. The nominations are decided by them.

Query 4: The information of Journalists who accompanied Hon'ble Prime Minister Shri Narendra Modi on his tours abroad is available on the Ministry's website www.mea.gov.in under the Head 'Visits' and subhead 'Outgoing Visits'.

2. In case the Applicant is not satisfied with the above response he may file an appeal with Shri R. Masakui, Director (PD) and Appellate Authority, Room No. 143, 'A' Wing, Shastri Bhawan, New Delhi within a month of the receipt of this letter.
