It may be mentioned that the number of vacancies for appointment on compassionate grounds on an annual basis, in the last few years has been in the range of one to two posts, against which the number of applications considered in any given year is about 30 to 40.

Shri Neeraj Kumar's name was shortlisted and he was considered along with other similar applicants for appointment in the Ministry on compassionate grounds during the year 2013-2014. His name is being kept in the waiting list and will again be considered by the selection committee for this year.
