- 2. This Division deals with West African countries. Among West African countries, Ex PM Dr. Manmohan Singh visited only one country viz...Nigeria during his two terms as Prime Minister. The details in r/o point No. (4) of the RTI application are given below:
 - i) Ex Prime Minister Dr. Manmohan Singh visited Abuja. Nigeria from October 14-16, 2007.
 - ii) The following Agreements were signed during the visit:
 - a) MoU on Defence Cooperation;
 - b) Protocol for Foreign Office Consultations;
 - c) MoU between MEA FSI and the Nigerian Foreign Office Service Academy; and
 - d) MoU between ICWA and Nigerian Institute of International Affairs
 - iii) During the visit, an Abuja Declaration on Strategic Partnership was issued laying out the future contours of the bilateral relations and
 - iv) During the visit, Ex PM addressed a Joint Session of Nigerian National Assembly on October 15, 2007.
- 3. Hon'ble Prime Minister Shri Narendra Modi has not visited any West African country so far since his oath taken in 2014. Hence, information in r/o point no. (8) of RTI application is 'Nil'.
