5. Kindly provide information whether the gifts received by Prime Minister are his personal property or they go to the treasury of the Central government.
6. Kindly inform about the gifts received during foreign visits of various prime ministers of India from 2000 to till date. Kindly provide the list of all. And also inform me that what happened to these gifts. Whether Prime Ministers took all these gifts with them after relinquishing office or they were left with the Central government.
7. Kindly provide the certified copies of the documents which permit the Prime Minister and other Ministers in the cabinet to have clothes made from the funds of the Central government.



2. It may be mentioned that Toshakhana deals with gifts received from foreign sources only. Your application has been transferred to under mentioned CPIO for reply of queries at Point Nos. 3,4,5 &6. The reply to your aforementioned application is given herewith point wise :-

Point No. 3: The details of all the gifts received by the Prime Minister since his assumption of office in May 2014 upto 31st December, 2014 are available on MEA's website and can be seen on the following hyperlink:-

<http://mea.gov.in/disclosure-of-gifts-received-in-toshakhana.htm>.

Information on this website is uploaded on quaterly basis. However, information regarding names of the source countries cannot be disclosed as the Ministry of External Affairs has been allowed by CIC vide its order No. CIC/AD/C/2009/000802 dated 21st December, 2009 (available on CIC's website) **to sever the information about the name/s of the donor of the gift viz. the name/s of the countries which had presented the gifts** in terms of the provisions of Section 10 (1) of the RTI Act, 2005.

Point No. 4: The gifts received by the Prime Minister from foreign sources are governed by Foreign Contribution (Acceptance or Retention of Gifts or Presentations) Rules, 2012 (available on MHA's website) which are equally applicable to other Ministers, MPs and officials.

Point No. 5: These gifts are either retained by the recipient or deposited in Toshakhana as per Foreign Contribution (Acceptance or Retention of Gifts or Presentations) Rules (available on MHA's website).

Point No. 6: The details of all the gifts (received from foreign sources either in India or outside) as per Toshakhana records since 1st July 2013 upto 31st December, 2014 mentioning their assessed value are available on MEA's website and can be seen on the following hyperlink:-



Information on this website is uploaded on quarterly basis. The information regarding names of the source countries cannot be disclosed as the Ministry of External Affairs has been allowed by **CIC in its order No. CIC/AD/C/2009/000802 dated 21st December, 2009** (available on CIC's website) to sever the information about the name/s of the donor of the gift viz. the name/s of the countries which had presented the gifts in terms of the provisions of Section 10 (1) of the RTI Act, 2005. Information regarding gifts received by the Prime Minister from foreign countries/sources with effect from May, 2004 to 30th June, 2013, after severing names of the donor countries/ sources has been attached herewith as Annexure-I. However, information about the Gifts received in Toshakhana (from foreign sources either in India or outside) from year 2000 upto April, 2004 is not readily available. It will have to be compiled. However, under RTI Act, 2005, the Public Authority is not required to collate information but to provide information as it already exists since collating the information will disproportionately divert resources of the Public Authority for which exemption has been provided under Section 7 (9) of the RTI Act, 2005. A majority of Gifts received by former Prime Ministers are in Toshakhana's custody. However, some gifts have been retained by them as allowed under Foreign Contribution (Acceptance or Retention of Gifts or Presentations) Rules (available on MHA's website).

3. In case you intend to prefer an appeal on the information provided by the under mentioned CPIO, the same may be preferred to the Appellate Authority Shri Sugandh Rajaram, Director (Establishment) , Room No. 4051, Jawaharlal Nehru Bhawan, 23-D, Janpath, New Delhi- 110011 within 30 days of receipt of this letter.
