"The gifts are selected as per the financial ceilings approved by the Government. The gifts may be purchased from any Government emporium which is willing to supply the desired items on credit basis to the Ministry. Meanwhile, as the information regarding gift norms is sensitive, it may not be possible to disclose the same. Exemption is, therefore, sought under section 8(1) (a) RTI act 2005."
