- In this connection, this is to state that the Prime Minister of India (3)presents gifts, as per the laid down norms, to various foreign dignitaries. Information sought by you relates to value/cost of the gifts presented by the PM to the US President and family. However, disclosure of this information may prejudicially affect India's relations with the concerned foreign State. Exemption is, therefore, sought under section 8(1) (a) RTI act 2005, wherein no such information as may prejudicially affect India's relations with a foreign State need be disclosed.
