- As far as allotment of country number to a vehicle of a diplomat/diplomatic Mission/Post is concerned, it is a classified information. Disclosure of this information may prejudicially affect India's relations with the concerned foreign State/s. Exemption is, therefore, sought under section 8(1) (a) RTI act 2005, wherein no such information as may prejudicially affect India's relations with a foreign State need be disclosed.
