RTI application of Shri. R. Logeswaran seeking information on money spent by Govt. of India on neighbouring countries.


With reference to email/letter of US (Nepal) dated 10.7.2014 on the above subject and based on the available information with this Mission, the following is conveyed:

Point no. 2. It is submitted that during the last 10 years the following amounts have been booked by the Mission under the Major Head 3605-Aid to Nepal, which is treated as assistance to Nepal mainly on account of small, intermediate and large development projects including contributions for economic assistance as budgetary support, assistance for flood control and conducting of elections in November 2013 in Nepal.

It is also mentioned that in addition to the above, payments are also being made by the Ministry directly for the large projects being implemented with Govt. of India grant assistance in Nepal.

Moreover, the Government of India has been providing assistance to Government of Nepal for raising/strengthening/ construction of embankments along the identified rivers in Nepal. In this regard, the total grant assistance disbursed till date is IRs. 2,052.75 million.
