## Subject: Information sought by Shri Vodela Suresh Babu under Right to Information Act 2005

Sir,

Reference your Application No. MOEAF/R/2015/80466/31 dated 26/10/2015, received on 17/12/2015, seeking information under Right to Information Act 2005.

- 2. The applicant has sought the following information:
  - (i) Latest Hard Copy of 4(1)(b) of your office in Telugu language. (Telugu is on our currency).
  - (ii) Statement of Foreign tours purpose & expenditure of your offices & concern ministers.
  - (iii) List of your websites & date of updated.
- 3. The following is the response of the CPIO:

For 2(i): The information sought by applicant is quite unclear. However, it is presumed that the applicant is seeking information under Section 4(1)(b) of the RTI Act, which deals with proactive disclosure of information. However, the applicant originally sought the information from CBEC and later on transferred to the undersigned and it is also completely not clear whether the information sought under Section 4(1) (b) of the RTI Act is from the Ministry or from CBEC. This is not being dealt with by the undersigned. Since proactive disclosure of information under Section 4(1) (b) falls under the domain of the RTI Cell, CPIO RTI Cell is being requested to provide information to the applicant.

**For 2(ii):** The undersigned is not in possession of the information related to foreign tours purpose & expenditure of officers and concern ministers. Here too the applicant is not clear on the foreign visits of which officers and ministers is seeking information. Hence, the undersigned could not transfer this part to any CPIO within the Ministry and expressing inability to respond.

**For 2 (iii):** The information sought is related to maintenance of web sites and date of their update. This information too is not under the custody of the undersigned. This part is being transferred to EGIT Division for a response to the applicant.

4. In case the applicant is not satisfied with the response given by the undersigned, the applicant may file an appeal within 30 days of the receipt of this communication to Shri Jaideep Mazumdar, Chief of Protocol and First Appellate Authority, Room No. 2001, Jawaharlal Nehru Bhawan, Ministry of External Affairs, 23D, Janpath, New Delhi-110011.
