The Ministry through bidding hired a CA Firm for the scrutiny of files submitted by PTOs. All the documents submitted by PTOs were scrutinized by C.A. firm under the supervision of a four member committee constituted for this specific purpose. Based on documents submitted by PTOs, the final list of qualified PTOs, inline with the PTO policy for Haj 2013-17 duly approved by Hon'ble Supreme Court of India was published. The Haj pilgrims quota will be released to qualified PTOs only who have been registered with the Ministry.

3. If you are aggrieved with the reply, you may file an appeal with Shri Mridul Kumar, JS (Gulf & Hajj), Ministry of External Affairs, South Block, New Delhi, within a month from the date of receipt of this letter.
