Please provide detailed information together with correspondence/file-notings/documents on under-mentioned aspects relating to recent visit of hon'ble Prime Minister of India Mr. Narendra Modi's visit to Nepal:

According to the reports in the national and international media, in his recent trip hon'ble PM paid a visit to the Pashupatinath Temple in Kathmandu, Nepal. According to the right to information act, I would like to ask the following questions.

- 1. Was hon'ble FM's visit to the Pashapatinath temple, Kathmanda a public visit or the private one?
- 2. The media reported that hon'ble PM, offered 2501 kgs of sandalwood, 2500 Kgs of Ghee and Rs 25 crore as a donation to the restoration of the temple. If this is true, what was the total money spent to buy the sandalwood and ghee? Please provide receipts, tenders, procurement orders, file-notings for the same to this petitioner.
- 3. How many trees were felled for the procurement of 2501 kgs of sandalwood?
- 4. According to the prevalent market rates as reported in the media, the 2501 kg of sandalwood costs over Rs. 4 crore and 2500 kg of ghee cost around Rs. 9,36.000 but as per the information given to the Election Commission during 2014 Lok Sabha elections by the hon'ble PM's, value of his total assets is Rs. 1.5 crore. Media reported that the visit and donation to the temple was hon'ble PM's private and no media-person or official accompanied him to the temple. Where did the money for all this come from?
- 5. In case, the government and tax-payers are bearing the cost of 2501 Kgs sandalwood. 2500 kgs ghee and Rs 25 crore as donations, kindly provide detailed information about the fund through which all of this was financed.
- 6. Are there any precedents and lists available of both visits and donations by all the Prime Ministers of India since independence to the religious places in India and abroad? If yes, kindly share a copy with the petitioner.
- 7. Is there any rule/law which regulates the gifts/donations which can be made by the PM to foreign religious, educational and cultural places/institutions? If yes, kindly share a copy with the petitioner.
- 8. According to the Schedule 2 of the Foreign Trade (Development and Regulations)
  Act, 1992, export of "Sandalwood in any form, but excluding finished handicraft products of sandalwood, machine finished sandalwood products, sandalwood oil are
