Only Para 4 of the Application relates to this Division and the following information is provided in response to the said Para:

a). Details of media officials, who accompanied Prime Minister on his official visits to various countries, along with their organization details, are available on the website of the Ministry of External Affairs – www.mea.gov.in under the head "Visits" and sub head "Outgoing visits". A copy of the Ministry's homepage showing the link to "Outgoing visits" and a printout of the "Outgoing Visits" page along with a sample copy of the list of media delegates who accompanied the Prime Minister during his recent visit to France, Germany and Canada is enclosed.

b). The expenditure on accommodation in respect of Government media such as Doordarshan, AIR and Photo Division was borne by the respective Ministries/Departments of the Government. In so far as officials of the National News Agencies viz. PTI, UNI, ANI TV and private media are concerned, it was borne by the respective organizations/individuals. There is no cost of travel as they accompanied the Prime Minister on the special flight.

2. In case the Applicant is not satisfied with the above response he may file an appeal with Shri R. Masakui, Director (PD) and Appellate Authority, Room No. 143, 'A' Wing, Shastri Bhawan, New Delhi within a month of the receipt of this letter.




