Reference is invited to your RTI Application No. AYUSH/R/2015/60226 dated 02.07.2015 which was transferred by Coordination Division vide their letter No. AA/551/17/2015 dated 04.08.2015 and received by this Division on 05.08.2015. In so far as this Division is concerned, following information is provided in response to your query:

Out of a total sanctioned budget of Rs. 192 Crores to Indian Council for Cultural Relations (ICCR), a sum of only Rs. 8 Crores was earmarked for organising International Day of Yoga (IDY) event by our Missions/Posts abroad.

Information on expenditure incurred by our Missions/Posts abroad in connection with celebration of the first International Day of Yoga on 21<sup>st</sup> June 2015 is not held by this Division.

Your kind attention is invited to the observation of Hon'ble Supreme Court on RTI Act, 2005 in Civil Appeal No. 6454 of 2011 wherein it, inter alia, noted that "where information sought is not a part of the record of a public authority, and where such information is not required to be maintained under any law or the rules or regulations of the public authority, the Act does not cast an obligation upon the public authority, to collect or collate such non-available information and then furnish it to an Applicant."

2. In case the Applicant is not satisfied with the above response he may file an appeal with Shri R. Masakui, Director (PD) and Appellate Authority, Room No. 143, 'A' Wing, Shastri Bhawan, New Delhi within a month of the receipt of this letter.
