Kindly refer to your RTI application dated 29 September, 2015 (received in this office on 12 October, 2015) seeking information on the foreign visits by PM Modi and NDA government Ministers/MPs and PM Manmohan Singh and UPA government Ministers.

2. In this regard, with respect to **Para 3** of the RTI, it is conveyed that PM Modi has not visited **Vietnam and Philippines** till now. No Minister of current NDA government visited **Philippines** so far. Hon'ble EAM Smt. Sushama Swaraj accompanied by a 6-member delegation visited Hanoi, **Vietnam** from 24 to 26 August 2014. Total expenditure incurred by our Mission in Hanoi is Rs. 3,14,887/- (the amounts in Rupees have been derived as per official rate of exchange of Rs. 60.64 equal to One US Dollar prevalent during the period). The details of expenditure incurred on the travel of EAM and delegation by IAF Embraer aircraft is not available in this office.

3. Shri Dharmendra Pradhan, Minister for Petroleum & Natural Gas was member of the official delegation accompanying Shri Pranab Mukherjee, Hon'ble President of India on State Visit to **Vietnam** from 14 to 17 September 2014. Expenditure on account of hotel accommodation was US \$ 480/- and Daily Allowance was US \$ 180/-, totalling to US \$ 660/-.

4. With respect to **Para 10**, it is conveyed that the following Ministers visited **Philippines** during NDA government period:


5. In case of **Vietnam**, with respect to **para 10** of the RTI, it is conveyed that "Prime Minister Dr. Manmohan Singh visited Vietnam from 28 to 30 October 2010 to participate in the 8th India-ASEAN Summit Meetings and 5th East Asia Summit. He was accompanied by a 17-member Official delegation and 29 other officials were accompanying. The security component was of 21 personnel and the media delegation comprising official audio, video, print and private media was of 34 personnel. Total expenditure on accommodation and daily allowance was Rs.44,85,061.

6. With respect to the second part of Para 10, in case of **Vietnam**, it is conveyed that under the RTI Act "bifurcation list" of UPA Government Ministers cannot be provided as the information required is scattered and collation of information would involve searching of voluminous records by a significant number of officials and an attempt to compile the information in the manner sought would disproportionately divert resources of the public authority, as provided under Section 7(9) of the RTI Act 2005.

7. Inputs with respect to other paras of the said RTI are not available in this office.

8. In case you are not satisfied with the above reply, you can file an appeal within 30 days from the date of receipt of this communication, under Section 19 (1) of the Right to Information Act, 2005 to the following:-
