6. Please also provide any correspondence/email/memo from the External Affairs Minister Smt. Sushma Swaraj and MEA officers asking for such consultation from Government/MEA officials. Please also include all records including associated File Notings associated with this. —
7. Please provide all the name of the officers and individuals who wrote to the UK authorities seeking facilitation of permission for Lalit Kumar Modi to travel out of the UK since May 27th 2014. Please provide copies of all such correspondence(sent and replies received) by these officers /individuals seeking permission for Lalit Kumar Modi's travel out of the UK. —
8. Please provide a copy of all records including any correspondence including letters/memos/documents/emails/calls from the Ministry of External affairs with any other authorities/individuals in India or abroad to facilitate the travel of Lalit Modi out of the UK. —
