Dear Sir/Madam,

Sub:-Application seeking Information under RTI Act, 2005.

I do hereby invite reference to various orders issued from time to time by Central Vigilance Commission (CVC), including the orders No. 30/VGL/60 Dated 15<sup>th</sup> April 1999 and Dated 02<sup>nd</sup> November 2001 and I seek the following information under the Right to Information Act 2005:-

2. The various orders of CVC including the above-mentioned circulars stipulate, inter alia, that in order to avoid developing of vested interests, the officials posted in a government department in 'sensitive' posts must be rotated every two/three years. As per the CVC guidelines, no official should be posted in a sensitive division/section for more than 3 years and after a deployment of maximum three years, an official should be shifted to a non-sensitive division/section. As per the guidelines, any section/division having dealing with secret papers, financial dealings, purchase orders, contracts, and security aspects are considered as 'sensitive'.

3. In this context, kindly provide the following information:

- Whether the Ministry comes under the purview of the guidelines of CVC;
- If so, whether the above guidelines and CVC's relevant orders are being followed in the Ministry in letter and spirit;
- The names and details of officials of the ranks of Assistants/ Section Officers/ Private Secretaries/ Under Secretaries/ Principal Private Secretaries/ Deputy Secretaries/ Sr. Principal Private Secretaries in the Ministries, who have been deployed for more than last 3 years, within the same division, where they have had to deal with either secret papers, financial dealings, purchase orders, contracts, and security aspects;
- CVC's guidelines also stipulate that the reports about implementation of rotational policy should be submitted to CVC every year. It may kindly be confirmed whether such reports have been furnished for the last 10 years.

4. In case the information is held by or related to another public authority, the application or such part of it as may be appropriate may be transferred to that other public authority under intimation to the undersigned as per Section 6(3) of RTI Act.
