Subject : Result of evaluation of Technical Bids opened on 18 July, 2018 and announcement of date of opening of Financial Bids of E-tender for providing Attestation/Apostille Support Services 2018 for the CPV Division, MEA.

As indicated in the E-tender document for providing Attestation/Apostille Support Services, 2018 for the CPV Division, Ministry of External Affairs, the evaluation of Technical Bids received in response to the said E-tender and opened on 18-07-2018 was done by the Tender Evaluation Committee. 2. Remaining two participants could not qualify at the Technical Bid stage due to reasons given below :

1	Muble solutions Pvt. Ltd.	Disqualified on following grounds : Address of 3 cities i.e. Goa, Guwahati and Raipur not provided, in the Technical Bid, Financial Bid exposed at the Technical Bid stage, ISO certificates were issued after the bid submission date.
2	Alankit Limited.	Scored 60 marks in evaluation. Which is below the qualifying marks (70)

It is also informed that the Financial Bids would be opened on 10-08-2018 at 1500 hrs in presence of representatives of 6 bidders listed in para 1 above (only one representative would be allowed to be present during the Financial Bid opening). The venue for opening of Financial Bids would be Room No.1063, A wing, Jawahar Lal Nehru Bhavan, Ministry of External Affairs, Maulana Azad Road, New Delhi. The representatives of 6 bidding companies are requested to bring with them duly filled and signed copies of Annexure G (Part I, II & III) in respect of each of 15 cities so as to enable the Ministry to carry out evaluation of their Financial Bids, the result of which would be intimated after the evaluation process.

3. Representatives of unsuccessful bidders i.e Muble Solutions Pvt. Ltd and Alankit Limited could collect the EMD drafts submitted by them from our office on any working day between 1000 to 1200 hrs. Representative of M/s Jetsave India Tours Private Limited, may also collect the EMD draft submitted by them as their Bids were not received by this office and they could not participate in the tender process.
