#### **SECTION II: TERMS AND CONDITIONS**

- 1. The Tender shall be neatly arranged, plain and intelligible. Each page of the Tender should be signed. - 2. The Bidders shall submit documentary evidence in respect of their technical capabilities and experience in providing of similar services.
- 3. Any tender received by HCI, Abuja after the deadline for submission of tenders will not be accepted.
- 4. The Firm concerned will be fully responsible for the safety and insurance of its employees.
- 5. In case of any ambiguity/ dispute in the interpretation of any of the clauses in this Tender Document, HCI, Abuja's interpretation of the clauses shall be final and binding on all parties.
- 6. Mission reserves the right to terminate the contract at any point of time during the tenure of contract, if the services are not found satisfactory or the contractor dishonours the contract. Decision of the Mission in this regard shall be final and binding upon the contractor.

## **SECTION III: GENERAL CONDITIONS OF CONTRACT (GCC)**

#### 1. Prices

- a. Price quoted by the Bidder and agreed to by HCI, Abuja shall be considered final and no price escalation will be permitted thereafter.

- c. All prices are to be quoted in Naira only.

#### 2. Taxes and Duties:

The rates quoted should be exclusive of all taxes and transport charges etc. VAT should not be included as the High Commission of India is exempted from VAT under the Vienna Convention.

# 3. Force Majeure:

HCI, Abuja may consider relaxing the penalty and delivery requirements, as specified in this document, if and to the extent that, the delay in performance or other failure to perform its obligations under the contract is the result of an Force Majeure.
