- (ii) EMD is compulsorily required to be uploaded in pdf. Format along with the Organisation Profile latest by 8<sup>th</sup> October, 2022 (Saturday). However, Hard copy of the EMD may be submitted in original to the Office of the undersigned at Room No. 1, CPV Division, Ministry of External Affairs, Patiala House Annex, Tilak Marg, New Delhi 110001, latest by 21<sup>st</sup> October, 2022 (Friday), as mentioned in "Annexure E" of original RFP.

- (iii) MSMEs are exempt from submission of EMD in accordance with GOI guidelines.
- (iv) According to OM No. F.1/2/2022-PPD dated 1<sup>st</sup> April, 2022 of Ministry of Finance, EMD of unsuccessful bidders during first stage which is technical evaluation etc. would be <u>returned within 30</u> (Thirty) days of declaration of results of first stage i.e. technical evaluation.
- (v) EMD with the Ministry for the purpose of tender will earn no interest.
- (vi) EMD will be forfeited on account of one or more of the following reasons:- i. The Bidder withdraws/ modifies his bid during the period of bid validity; (b) In case the Selected Bidder fails to sign the Contract in time and furnish performance guarantee.
