Please refer to your RTI request registration no. MOEAF/R/T/24/00636 (& MHOME/R/T/24/03168/1) which was received at the undersigned CPIO on 18.11.2024.

- With regard to the information requested at points 1,2, 5 & 6, under so-called China-Pakistan 2. 'Boundary Agreement' signed in 1963, Pakistan illegally ceded 5,180 sq. kms of Indian Territory in Shaksgam Valley from areas illegally occupied by Pakistan in Union Territory of Ladakh to China. Government of India has never recognized the so-called Pakistan-China 'Boundary Agreement' of 1963 and consistently maintained that it is illegal and invalid. Indian territory under occupation of China in the Union Territory of Ladakh is approximately 38,000 square kilometers. The entire Union Territories of Jammu & Kashmir and Ladakh, have been, are and shall be an integral part of India. This fact has been clearly conveyed to Chinese authorities on several occasions. This Ministry has answered several Parliament Questions on this issue which are available in public domain.
- The undersigned CPIO is not in possession of any further information on this. It is also stated that 3. under the provisions of RTI Act 2005, a CPIO/ Public Authority is under obligation to provide an applicant only that information which exists in records and that which is held by or under the control of that authority.
- 4. If you are aggrieved with this reply, you may file an appeal to Shri Aniket Govind Mandavgane, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi -110011, within a month from the date of receipt of this letter.
