India-Bahrain Bilateral Relations

Summary

India and Bahrain enjoy excellent bilateral relations characterized by cordial political, economic, cultural and people to people contacts. Bahrain has genuine warmth towards India and this comes out in the interactions. Bahrain is keen on seeking greater economic engagement with India as Bahrain recognizes the importance and potential of the growing Indian economy and its Look East Policy in recent times has India as a major pivot. Presence of close to 340,000 Indian nationals who comprise nearly a quarter of the total population of 1.5 million in Bahrain is an important anchor of our bilateral relations.

History

2. Our bilateral trade and commercial exchanges go back about 5,000 years, tracing their origins to the period of Dilmun Civilization in Bahrain & Indus valley civilization. Ancient Bahraini traders are believed to have carried out flourishing trade of Bahraini pearls with spices from India with many of Bahrain's prominent figures having had close Indian connections. When Bahrain was a British protectorate, Indian Rupee was a legal tender in the country.

Political relations

3. The bilateral relationship is marked by regular high-level visits and exchanges. PM's visit to Bahrain in August 2019 following King Hamad's visit to India in 2014 has elevated our bilateral ties to newer heights.

Multilateral Institutional Mechanisms

- 4. **International Solar Alliance (ISA):** Bahrain joined ISA as its 86th Member on March 2022 as it deposited the Instrument of Accession on the sidelines of the 5th Foreign Office of Consultations held in New Delhi on 28 March 2022.
- 5. **Combined Maritime Forces (CMF):** India joined CMF as Associate Partner in July 2022 and as a full member in 2023, which was announced in the Joint Statement of fifth Annual India US 2+2 Ministerial Dialogue on 10 November 2023.

Recent developments:

6. **Joint Action Plan:** : On 13 November 2023, Central Board of Indirect Taxes & Customs, Government of India and Bahrain Customs signed a Joint Action Plan (JAP) regarding Mutual Recognition Arrangement of the respective Authorised Economic Operators Programmes.

Cooperation on COVID-19 matters

7. Both countries have had excellent cooperation in dealing with COVID and its aftermath. The Govt. of Bahrain provided food, medical and other necessary support to the Indian community, besides providing free COVID 19 vaccination to all in Bahrain, including the Indian community. Bahrain provided 40 MTs of liquid medical oxygen and facilitated COVID-19 related supplies to India in the month of May 2021, during the second COVID wave. The Govt. of India gifted 100,000 doses of 'Made-in-India' COVISHIELD vaccines to Bahrain on 28 January 2021. Govt. of India also provided 1.5 million Hydroxychloroquine tablets on commercial basis and facilitated travel of nurses and medical professionals to Bahrain, besides keeping supply lines open for Bahrain and other GCC countries for essential trade, food products and medicine etc.

Culture, Education & Youth:

- 8. **Culture:** The Cultural and People to People relations between the two countries date back centuries. The 200 year old Shreenathji temple is a testament to this. A **Cultural Exchange Programme 2019-2023** was signed between India and Bahrain during PM's visit to Bahrain in 2019. Within the ambit of CEP 2019-2023, several cultural festivals were held. Three editions of Indo-Bahrain dance and music festivals were held in 2022, 2023 and 2024. The Golden Jubilee of establishment of diplomatic relations between India and Bahrain was celebrated in association with Bahrain Authority for Culture & Antiquities (BACA), and MoFA, Bahrain from October 2022 to October 2023, including performances, stalls depicting Indian culture and seminars. Indian cultural troops also participated in cultural festivals of Bahrain.
- 9. Golden Jubilee Celebrations: Golden Jubilee of establishment of diplomatic relations between India and Kingdom of Bahrain was celebrated with a series of events in 2021-22. The celebrations started with the visit of INS Kochi from 15 - 18 August, 2021 and with the launch of Golden Jubilee Logo on 19 September, 2021. On 12 October 2021, Hon'ble EAM Dr. S. Jaishankar met and exchange greetings with Minister of Foreign Affairs of Bahrain, H.E. Dr. Abdullatif bin Rashid Al Zavani on the occasion of Golden Jubilee of India-Bahrain diplomatic relations on the sidelines of CICA Conference. The main week of celebrations was held from 12 to 19 October, 2021 at the historic Little India in Bahrain/ Bab-al-Bahrain in association with Bahrain Authority for Culture & Antiquities (BACA) and Ministry of Foreign Affairs. The Celebrations began on 12 October with historic event of illumination of Bab Al Bahrain in Indian tricolour and Outub Minar in Bahraini national colours. The festival was jointly inaugurated by H.E. Shaikha Mai bit Mohammed Al Khalifa, President, BACA; H.E. Mr. Tawfeeg Al Mansoor, Undersecretary, MoFA; and Ambassador. The events organized included seminars, webinars, cultural programmes, art exhibitions, poetry meets, and stalls showcasing handicrafts, food and cuisines etc. Two major events were held in 2022, a Multilingual Poetry Meet 'Sadaqatu Dosti Ka' hosted at the Embassy in December 2022 with poems from Indian and Bahraini poets in Hindi, Arabic, Urdu and English; and an "Indo-Bahrain Art Exhibition" held in Dana Mall, Manama to bring together 50 Artists from India and Bahrain.
- 10. **Youth**: H.E. Minister of Youth and Sport Affairs of Bahrain held two virtual meetings with H.E. Minister of Youth Affairs and Sports of India on 16 September 2021; and with H.E. Minister of Education and Skill Development and Entrepreneurship of India on 23 December 2021. Both sides agreed to increase cooperation in the field of sports and youth exchanges and cooperation in the field of training/internship, start-ups and upskilling and reskilling. A 3-member youth represented Bahrain as a guest country in the Y-20 Summit held in Varanasi from 17-20 August 2023.
- 11. **Education**: A number of prominent Bahrainis had studied in India in the past. Bahrain also has eight Indian schools with around twenty-two thousand students. Both sides are now working to further intensify cooperation in the field of Education.

Trade and Economic Relations

13. India-Bahrain bilateral trade and commercial exchanges go back about 5,000 years

tracing their origins to the period of Dilmun Civilization in Bahrain and Indus valley civilization in India. Ancient Bahraini traders are believed to have carried out flourishing trade of Bahraini pearls with spices from India. In contemporary times, these relations received fresh impetus from the oil boom of the early seventies. Oil exports from Bahrain and relative prosperity and higher standard of living in Bahrain boosted its share in global trade of goods and services, including to/from India. Bahrain Government's policy of industrial diversification also played an important role in enhancing economic cooperation between India and Bahrain. Bilateral trade in 2023-24 has reached USD 1.7 billion. India is among the top five trading partners of Bahrain. Bilateral trade figures are as under:

- 14. **Major items of exports to Bahrain are**: agri products (Rice, boneless meat, shrimp, sugar, fresh fruits and vegetables), machinery & engineering goods, medicaments (recent addition), jewellery, polymers, private cars, ships, boats and floating structures.
- 15. **Major items for imports from Bahrain are**: urea, methanol, mineral fuel, mineral oils & products, iron ore, aluminum, copper and bridge sections.

Indian investment in Bahrain

16. Bilateral investments have increased from both directions in the recent time. As per the data of Economic Development Board of Bahrain, India is the 6th largest investor in Bahrain. Cumulative Indian investment in Bahrain has reached approx. \$1.5 billion increasing by more than 35% since 2019. Financial services accounts for the highest investment value. Other important areas of investment are real estate, hospitality, health, IT and education. 38 Indian commercial agencies, 32 branches of prominent Indian companies and more than 7500 Indian owned/India Joint Venture companies registered in Bahrain as on October 2020.

Bahraini investment in India

17. Bahrain's investments into India have also shown increasing trend recently. As per DIPP statistics, total cumulative investment from Bahrain to India from is about USD 185

million (in December 2013, it was only at USD 31.55 million). The main sectors of Bahrain's investment into India are real estate, information technology and engineering.

Indian Expatriate Community

- 18. The Indian community in Bahrain is the largest expat community in Bahrain. The presence of a large Indian expatriate workforce at all levels from unskilled to professionals continues to remain an important anchor of India-Bahrain bilateral relations.
- 19. While there were only 90,000 Indian nationals working in Bahrain in the year 2000, the number has since increased to over 340,000 comprising of 200,000 from Kerala, 50,000 from Tamil Nadu, 40,000 from Andhra Pradesh & Telangana, 25,000 from Karnataka and rest from Punjab, Rajasthan, UP, Maharashtra, Goa and Gujarat. In addition to about 2/3rd being skilled and semi-skilled workers and labourers, there is a sizeable number of businessmen, CEOs, CFOs, doctors, nurses, engineers, chartered accountants, bankers, managers, teachers and other professionals who play a vital role in the Bahrain's socioeconomic development.
- 20. Bahrain launched 'Little India in Bahrain' project in November 2015 to acknowledge and mark the contribution of Indian community to the history and progress of Bahrain. Under the project, exterior of various buildings were restored and renovated, as well as a small public space. The main event of the Golden Jubilee of Diplomatic relations was held at the renovated 'Little India in Bahrain' in October 2021. Bahrain also hosts a 200 year-old Shreenathji Temple in Bahrain at the heart of Manama which is the oldest Hindu temples in the region. PM Shri Narendra Modi had inaugurated the renovation of the temple during his visit in August 2019, which was earmarked as a special project by Bahraini Ministry of Housing and Urban Planning in September 2023. Bahrain has also approved allocation of land for a new BAPS Swaminarayan Temple in January 2022.
