

## **India-Saudi Arabia Bilateral Brief**

India and the Kingdom of Saudi Arabia enjoy close friendly relations reflecting the centuries old economic and socio-cultural ties. Diplomatic relations were established in 1947. The historic visit of King Abdullah to India in January 2006 was a watershed moment that resulted in the signing of the 'Delhi Declaration'. It was followed later by the 'Riyadh Declaration' in 2010 during the visit of Hon'ble Prime Minister Dr. Manmohan Singh to the Kingdom, which elevated the bilateral relations to a Strategic Partnership.

2. The visit of Hon'ble PM Shri Narendra Modi to Riyadh in April 2016 led to an enhanced and comprehensive cooperation in the political, economic, security and defence realms. During the visit, King Salman conferred the Kingdom's highest civilian honor, the 'King Abdulaziz Sash', on the Hon'ble PM. The visit of HRH Prince Mohammad bin Salman, Crown Prince of Saudi Arabia, to India in February 2019 further carried forward this momentum. During the visit, it was announced that the Kingdom would invest approximately USD 100 billion in India and 06 MoUs/Agreements were signed in various fields, including investment, tourism, housing, exchange of audio-visual programmes, and an agreement was signed to pave way for Saudi Arabia to join the International Solar Alliance (ISA).

3. Hon'ble PM visited Riyadh again on October 28-29, 2019, during which the Strategic Partnership Council Agreement was signed, establishing a high-level council to steer the India-Saudi Arabia relationship. 12 MoUs/Agreements were signed during the visit across several fields, including energy, security, defence production, civil aviation, medical products, strategic petroleum reserves, small and medium scale industries, and training of diplomats. During the visit, Hon'ble PM also delivered the keynote address at the 3<sup>rd</sup> Future Investment Initiative Summit.

4. HRH Prince Mohammed bin Salman, Crown Prince & PM of Saudi Arabia, visited India on September 9-11, 2023 to participate in the G20 Leaders' Summit and to co-chair the 1<sup>st</sup> Leaders' Meeting of the India-Saudi Arabia Strategic Partnership Council along with Hon'ble PM Shri Narendra Modi. During the visit, 08 MoUs/MoCs/Agreements were signed across several fields including energy, banking, investment, manufacturing, archival cooperation, anti-corruption and water desalination. There have been several high level engagements across sectors over recent years. A list of incoming/outgoing Ministerial visits is enclosed as **Annex-I**.

### **Economic Cooperation**

5. Bilateral trade ties have steadily grown over the years. India is the 2<sup>nd</sup> largest trade partner of Saudi Arabia whereas Saudi Arabia is the 5<sup>th</sup> largest trading partner of India. In FY 2023-24, bilateral trade stood at USD 42.98 billion, with Indian exports at USD 11.56 billion and imports at USD 31.42 billion.

6. Indian investments in Saudi Arabia have also increased in recent years, reaching cumulative figure of approximately USD 3 billion in August 2023. These investments are across diverse sectors such as management and consultancy services, construction projects,

telecommunications, IT, financial services and software development, pharmaceuticals, etc. Major Indian companies and corporate groups such as L&T, TATA Motors, Wipro, TCS, Shapoorji & Pallonji, Tech Mahindra, Vedanta, Essar etc., have established a strong presence in the Kingdom. Major Indian companies and corporate groups such as L&T, TATA, Wipro, TCS, TCIL, Shapoorji & Pallonji, etc. have established a strong presence in Saudi Arabia.

7. The Saudi investment in India including that of PIF, other Saudi companies and Saudi backed Vision Fund, has been about USD 10 billion. Major investments include PIF's investments in Reliance Jio Platforms (USD 1.5 billion to acquire a 2.32% stake) and Reliance Retail Ventures Limited (USD 1.3 billion to acquire a 2.04% stake). In 2020, the PIF - owned Saudi Agricultural & Livestock Investment Company (SALIC) has acquired a 30% stake in Daawat Foods Ltd. through its subsidiary United Farmers Investment Company, for a value of USD 17.23 million. In 2022, SALIC purchased a 9.2% stake in the India-based LT Foods Limited totaling USD 44 million. In July 2021, Elm, a company-owned by PIF, has invested in India-based health tech Healthifyme's USD 75 million Series C funding round. Apart from PIF, major investment groups from the Kingdom include ARAMCO, SABIC, AlFanar ZAMIL, Abdul Latif Jameel, Al Jomaih and Petromin. Al Fanar has invested approximately USD 700 million in wind and solar projects in Gujarat and Rajasthan.

8. The first meeting of Joint High Level Task Force on Investment (HLTFI) was held in July 2024. In early April 2025, executive level meetings of HLTFI took place in Riyadh. HLTFI was agreed upon by both sides during the visit of HRH Prince Mohammed bin Salman, Crown Prince and PM, to India in September 2023. The first India-Saudi Investment Forum was organized on the sidelines of this visit which was co-chaired by Minister of Commerce and Industry, Shri Piyush Goyal and the Saudi Minister of Investment, H.E. Khalid Al Falih. More than 50 MoUs (B2B and B2G) were signed during this Forum.

### **Energy Partnership**

9. Saudi Arabia remained India's third largest Crude and Petroleum products sourcing destination for FY 2023-24. India imported 33.35 MMT of crude oil in FY 2023-24 from Saudi Arabia, accounting for 14.3% of the India's total crude oil imports. In FY 2023-24, Saudi Arabia was the 3<sup>rd</sup> largest LPG sourcing destination for India, accounting for 18.2% of the total LPG imports of India for 2023-24.

### **Defence Partnership**

10. India-Saudi Arabia defense partnership has strengthened in recent years. The first ministerial visit on the defence side in over 12 years took place when Hon'ble MoS (Defence) Shri Ajay Bhatt visited Riyadh for the World Defence Show in February 2024. The Indian Chief of Army Staff, General Manoj Mukund Naravane, visited Saudi Arabia in December 2020. Being maritime neighbors, India and Saudi Arabia enjoy extensive naval cooperation. As of date, two editions of the bilateral naval exercise 'Al Mohed Al Hindi' have been concluded. The first ever India-Saudi Joint Land Force Exercise 'EX-SADA TANSEEQ-I' was conducted in India from January 29 - February 10, 2024. The first official visit to India by a Royal Saudi

Naval Forces Chief of Staff (Admiral Fahd Al-Ghofaily) took place in January 2024. An Indian Navy delegation participated in the 3<sup>rd</sup> Saudi International Maritime Forum on November 19-21, 2024.

11. Additionally, both sides are also having close cooperation in the domain of defence industries and capacity building. During the visit of Hon'ble MoS (Defence) Shri Ajay Bhatt to Kingdom in February 2024, an agreement was signed by Munitions India Ltd. for defence export from India to Saudi Arabia worth USD 225 million. The 6<sup>th</sup> meeting of Joint Committee Defence Cooperation under PSSC was held in Riyadh on September 3, 2024.

### **Cultural Relations**

12. India and Saudi Arabia enjoy a long history of cultural engagements. In recent years, bilateral cultural activities have accelerated in line with Saudi Arabia's Vision 2030. India participated as the 'Guest of Honour' at the 32<sup>nd</sup> edition of the prestigious Saudi National Festival of Heritage and Culture 'JANADRIYAH' from February 07-28, 2018. The festival was inaugurated by King Salman in the presence of the then External Affairs Minister Smt. Sushma Swaraj.

13. Yoga has also become a very popular activity in Saudi Arabia, particularly after it was recognized as a 'sports activity' in November 2017. In 2018, Ms. Nouf Al-Marwaai, a Saudi national, was awarded with Padma Shri in recognition of her efforts in popularizing Yoga in Saudi Arabia. On the occasion of International Day of Yoga (IDY) 2021, an MoU on Yoga Cooperation was signed between the Saudi Ministry of Sports and the Indian Ministry of AYUSH, which paved the way for the establishment of formal Yoga standards and courses in the Kingdom, marking the first time such standards were being implemented by any country in the Gulf region. On the occasion of the 10<sup>th</sup> IDY in 2024, for the first time, a lady instructor from Saudi Arabia led the common yoga protocol during the Yoga Day celebrations organized by the Embassy of India, Riyadh in collaboration with Saudi Ministry of Sports.

14. In October 2024, a five member delegation from the National Archives of India visited Riyadh to attend training courses at the King Abdulaziz Foundation under the bilateral MoU on archival cooperation. Indian cultural fortnight was celebrated at Suwaidi Park under the aegis of Riyadh Season in October 2024. The Embassy organized a musical performance by Sarod maestro Shri Amjad Ali Khan on February 6, 2025 in Riyadh. India-Saudi Arabia cultural cooperation has also been expanding in the areas of cinema and entertainment, sports activities such as cricket and football and tourism exchange.

15. Through cultural initiatives like Pravasi Parichay, launched by the Embassy of India in Riyadh in 2023, the rich tapestry of India's cultural heritage has been highlighted in Saudi Arabia. The second edition of Pravasi Parichay, held in October 2024, showcased the incredible diversity of Indian culture. With participation from over 450 artists representing 14 Indian states, the festival featured an impressive array of cultural performances, including folk dances, classical music, drama, and literature.

## **Indian Community in Saudi Arabia**

16. The Indian community in Saudi Arabia numbers at approximately 2.7 million and is a living bridge between the two countries. Indian diaspora is widely respected in the Kingdom for their contributions in the development of Saudi Arabia. The contributions made by the Indian community to the development of Saudi Arabia are well acknowledged. Dr. Syed Anwar Khursheed, a doctor resident in Saudi Arabia, was awarded the Pravasi Bharatiya Samman Award for 2025 in Bhubaneshwar in January. In March 2022, an Agreement on Skill Verification Program was signed between NSDC, Indian Ministry of Skill Development and Entrepreneurship, and Takamol holding, Saudi Ministry of Human Resources and Social Development. Since then, the Skill Verification Program has also been initiated between India and Saudi Arabia. The two countries have also signed Agreement for Domestic Sector Workers in the year 2014 and Agreement for General Category Workers in 2016.

17. The annual Hajj pilgrimage is another important component of India-Saudi Arabia bilateral relations. During Crown Prince's visit to New Delhi in February 2019, it was announced that India's Hajj quota would be increased by 24,975 in 2019, enabling 2,00,000 Indians to perform Hajj in August 2019. Following the restrictions imposed during the pandemic, India's Hajj quota was again resumed to 175,025 pilgrims in 2023. India has also digitized the Hajj process by providing the Hajj mobile app, health facility-e-MASIHA, e-luggage pre-tagging, and linking the HGOs (Hajj Group Organizers) with the digital system, which has simplified the procedures for pilgrims.

**Hon'ble Minister of State for Finance** Shri Pankaj Chaudhary visited Riyadh on December 4, 2024 to attend the Zakat, Tax, and Customs Authority (ZATCA) Conference 2024.

**Hon'ble Minister of Environment, Forest and Climate Change** Shri Bhupender Yadav visited Riyadh on December 2-3, 2024 to participate in the 16<sup>th</sup> Conference of the Parties (COP16) of the United Nations Convention to Combat Desertification (UNCCD).

**Hon'ble Minister of State for Health and Family Welfare** Ms. Anupriya Patel visited Jeddah on November 15-16, 2024 to attend the 4<sup>th</sup> Global High-Level Ministerial Conference on Anti-Microbial Resistance (AMR). She also met Saudi Minister of Health Fahad bin Abdulrahman Al Jalajel.

Both Ministers witnessed signing of a Feasibility Agreement between Central Transmission Utility of India Ltd. and Saudi National Electricity Transmission Company (National Grid), Saudi Arabia.

Hon'ble Minister of External Affairs Dr. S. Jaishankar visited Riyadh on September 8-9, 2024. During the visit, EAM attended the first ever India-GCC Joint Ministerial Meeting for Strategic Dialogue. A Joint Action Plan 2024-28 was adopted at the meeting. He also held a bilateral meeting with Saudi Minister of Foreign Affairs Prince Faisal bin Farhan Al Saud.

Comptroller and Auditor General of India Shri Girish Chandra Murmu visited Riyadh on August 28-31, 2024 for bilateral meetings and signing of MoU with the General Court of Audit of Saudi Arabia for cooperation in the field of audit.

Secretary (CPV & OIA), Ministry of External Affairs Shri Muktesh K. Pardeshi visited Madinah, Jeddah and Riyadh on May 4-7, 2024. During his visit, he met with the Saudi Vice Haj & Umrah Minister Dr. Abdul-Fattah bin Sulaiman Mashat, President & Interim CEO of Saudi Center for International Strategic Partnerships Mr. Raad Al Barakati, Assistant Secretary General of the Gulf Cooperation Council Dr. Abdulaziz Aluwaisheg, Deputy Minister for Political Affairs at Saudi Ministry of Foreign Affairs Dr. Saud Al Sati, and Assistant Ministers at Saudi Ministry of Energy Mr. Mohammed Albrahim and Mr. Nasser Al Qahtani.

She attended the 3<sup>rd</sup> edition of Haj and Umrah Conference organised by the Saudi Ministry of Haj and Umrah Affairs. She also met Saudi Minister of Haj and Umrah Affairs Dr. Tawfiq bin Fawzan Al Rabiah. The two Ministers signed the Bilateral Haj Agreement 2024. Hon'ble Minister of State for External and Parliamentary Affairs Shri V. Muraleedharan also accompanied the Hon'ble Minister of Minority Affairs.

**Hon'ble Minister of Commerce & Industries and Textiles and Consumer Affairs, Food & Public Distribution** Shri Piyush Goyal visited the Kingdom on October 24-25, 2023 to participate in the 7<sup>th</sup> edition of Future Investment Initiative Forum 2023. During the visit, the Hon'ble Minister met the Saudi Minister of Energy Prince Abdulaziz bin Salman Al Saud, Minister of Investment Mr. Khalid Al Falih, Minister of Industry & Mineral Resources Mr. Bandar Alkhorayef, and Minister of Commerce Mr. Majid bin Abdullah Al Qasabi.

During the visit, the two sides signed an MoU in the field of Electrical Interconnection, Green/Clean Hydrogen and Supply Chains.

Hon'ble Minister of State for Tourism and Ports, Shipping and Waterways of India Shri Shripad Yesso Naik visited Riyadh on September 27-29, 2023 to attend the World Tourism Day 2023 celebrations organised by the UNWTO and the Saudi Ministry of Tourism in Riyadh. He also had interaction with Saudi Minister of Tourism Mr. Ahmed Al Khateeb during the visit.

**Hon'ble Minister of State for External and Parliamentary Affairs** Shri V. Muraleedharan paid an official visit to Riyadh on May 1-3, 2023. Prior to this, he had also visited Jeddah on April 25-28, 2023 to lead the evacuation exercise under Operation Kaveri.

**Hon'ble Minister of Commerce & Industries and Textiles and Consumer Affairs, Food & Public Distribution** Shri Piyush Goyal visited Riyadh on September 18-19, 2022. During the visit, Hon'ble Minister co-chaired the inaugural Ministerial meeting of the Economic and Investments Committee, along with the Saudi Minister of Energy Prince Abdulaziz bin Salman Al-Saud. In addition, he also met Saudi Minister of Commerce Majid bin Abdullah Al Qasabi. He also held detailed discussions on avenues of commercial cooperation with the heads of Royal Commission for Riyadh City (RCRC), Saudi Exim bank and with prominent business persons in the Kingdom.

**Hon'ble Minister of External Affairs** Dr. S. Jaishankar visited Saudi Arabia on September 10-12, 2022. During the visit, EAM called on Crown Prince Mohammed bin Salman, and co-chaired the inaugural Ministerial meeting of the Committee on Political, Security, Social and Cultural Cooperation (PSSC) with the Saudi Minister of Foreign Affairs Prince Faisal bin Farhan Al Saud. He also met the Secretary General of the Gulf Cooperation Council Dr. Nayef Falah Mubarak Al-Hajraf – during which the two sides also signed an MOU on Mechanism of Consultations between India and the GCC.

**Hon'ble Minister for Health & Family Welfare and Chemicals & Fertilizers** Dr. Mansukh Mandaviya visited Riyadh on August 25-26, 2022. During his visit, he held bilateral consultations with the Saudi Minister of Environment, Water and Agriculture, Abdulrahman Abdulmohsen A. AlFadley and Saudi Minister of Industry and Mineral Resources Bandar AlKhorayef. He also held discussions, with the heads of SABIC and Maaden, regarding India-Saudi cooperation in the field of chemicals and fertilizers.

#### *Saudi Arabia to India*

Saudi Minister of Industries and Mineral Resources Bandar Alkhorayef visited New Delhi and Mumbai on February 3-6, 2025. He met Minister of Commerce & Industry, Minister of Chemicals and Fertilizers, Minister of Heavy Industries, and Minister of Coal & Mines.

Saudi Minister of Foreign Affairs Prince Faisal bin Farhan visited New Delhi on November 12-13, 2024. EAM and Saudi Minister co-chaired the ministerial meeting of the PSSC committee of India-Saudi SPC. Both sides discussed avenues to strengthen the strategic partnership between India and Saudi Arabia in the areas including trade, investment, energy, defence, security, culture and consular matters. They also exchanged views on regional and international issues of mutual interest.

Admiral Fahad Abdullah S. Al-Ghofaily, Chief of Staff, Royal Saudi Naval Forces visited New Delhi on January 10-13, 2024. Al-Ghofaily called on Admiral R. Hari Kumar, the Chief of the Naval Staff, and held discussions on mechanisms and measures to further strengthen Navy to

Navy cooperation. He met with the Chief of Defence Staff, Defence Secretary, Chief of Air Staff, Vice Chief of Army Staff, and the Secretary (CPV & OIA), MEA.

Saudi Minister of Hajj and Umrah Dr. Tawfiq bin Fawzan Al-Rabiah visited India on December 5, 2023.

President of the Saudi Shura Council Dr. Abdullah Mohammed Ibrahim Al-Sheikh visited India in October 2023 to participate in the G20 Parliamentary Speakers' Summit.
